

## **The Food and Drink Foundation Sector Definition**

Since 2014 the Food and Drink sector has been reported statistically using the definition of the “Food and Farming Priority Sector”. This was agreed to support the 2014–2020 Food and Drink Action Plan (Towards Sustainable Growth), with the primary target to grow the food and farming priority sector to a value of £7billion in turnover by 2020.

From 2020 we are adopting a new “Food and Drink Foundation Sector” definition. The change of focus is for two reasons. First, it reflects the Welsh Government’s policy to develop a ‘foundational economy’, which specifically includes the secondary elements of the food sector (i.e. food and drink manufacture and processing) as an important element. Second, the change will more accurately track and analyse the performance of the areas directly impacted through the focus of Food and Drink Wales policy and support. The primary differences will be the removal of agricultural classifications and adding in areas of manufacture and wholesale within the food and drink supply chain (such as food product packaging manufacture), which are more aligned to the foundation sector status of food and drink.

Given the difference of SIC codes comprising the foundation and priority sectors, it is important not to compare the values across these two sectors. Doing so will provide values which hold no meaning and will likely result in incorrect or misrepresented analysis.

The full breakdown of the SIC categories included in both the new food foundation sector, and the previously used food priority sector, can be seen in the tables below.
