

New Measures for Moving Animal Products, Plants and Plant Products From Great Britain to Northern Ireland

The United Kingdom (UK) left the European Union (EU) on 31 January 2020 and since then, we have been in a transition period where the UK Government works with the EU to reach a trade agreement.

The Government has published a <u>Command Paper</u> setting out the details of an agreement in principle on the implementation of the Northern Ireland Protocol. As a result, from the 1 January 2021, new measures and procedures for traders who move animal products, plants and plant products from Great Britain (GB) to Northern Ireland (NI) will come into force.

We encourage businesses to start thinking about the appropriate and relevant actions they will need to take in order to be best placed for the new requirements and opportunities that lay ahead.

To assist you with the new measures, we have organised several webinars that will provide you with further information to enable you to continue to move animal products, plants and plant products from Great Britain to Northern Ireland.

The webinars will incorporate the end to end process and journey for moving products from Great Britain to Northern Ireland. They will take you through the preparation and the steps to continue moving your products and what checks to expect when they arrive in Northern Ireland.

Additionally, we have arranged for an Export Health Certificate (EHC) webinar recording to be made available on GOV.UK for traders who will require EHCs. This will take you through the requirement, a demonstration of the EHC Online service and covers how to obtain an EHC.

Supporting Businesses

As traders will need to understand and comply with new sanitary and phytosanitary (SPS) requirements designed to protect human, plant, and animal health when moving products to and through NI, Defra is introducing a new scheme. Known as the Movement Assistance Scheme (MAS), it will provide various levels of support to traders.

One level of support is a dedicated contact centre where businesses can call for advice on moving products from GB to NI.

This service will be available from 16 December 2020 and will be able to support you with understanding the policy changes and providing practical support. Specialist advisors will be able to advise on matters such as Export Health Certificates, animal products, plants and plant products.

Secondly, the scheme will provide financial assistance for traders moving food or agricultural products for which specific SPS controls apply—meaning the UK Government will cover, for example, reasonable costs for obtaining Export Health Certificates. Businesses can be assured that despite the new requirements of the Protocol, businesses will be supported to deal with new direct costs.
